2011 PENDLETON FARMERS MARKET GUIDELINES



The Pendleton Farmers Market (hereinafter called the "Market") has been developed to be primarily a farmer and grower market that meets the needs of the Pendleton area community. The Market operates under and is managed by the Town of Pendleton. Market guidelines have been established to provide regulations specific to the Market and are subject to change. These guidelines are mandatory for all farmers, growers, crafters and food vendors. ALL products are subject to decisions of the Town of Pendleton and the Pendleton Farmers Market Manager.

Operating Hours:

Thursdays, 4:00pm to 6:00ish and Saturday's from 10am to 1pm typically June through September. Farmer/vendor set-up begins at 3:00pm on Thursday's and 9am on Saturday's. Market begins with a Bell Ringing promptly at 4pm and 10am. Absolutely NO sales will be permitted prior to the bell ringing. The Market will be cancelled in the event of heavy rainfall or storms.

Vendor Fees:

All vendors will be required to pay a \$5 per day fee. The market manager will collect the market fee at time of set-up.

Vendor Space:

Vendors will be assigned a location. Space preference will be given to last year's participants in good standing. Vendors will be placed in accordance to availability. Littering is prohibited. All trash should be taken with you or disposed of in containers provided by the Town of Pendleton.

Insurance:

The Pendleton Farmers Market does not carry insurance to cover individual Market participants. **All vendors are required to carry their own product liability insurance and must have certificate with them during market hours.** The Town of Pendleton shall be reimbursed for any damage to the Farmers Market property by any of the Market participants. This includes damage to sidewalks, grounds, vehicles, and any other property owned by or provided by the Town of Pendleton.

Farmers & Growers:

To be considered an eligible participant in the farmer/grower status, Market participants must be a bona fide farmer or grower within a 100 mile radius of the tri-county area. The Town of Pendleton will consider farmers who are not located in the tri-county area. The Pendleton Farmers Market does not accept brokers; participants who have bought produce, plants or flowers from a grower for resale. Farmer/Grower agrees to display a sign indicating his/her farm name, produce/plant name and price. All farms are subject to inspection by the market manager or representative of the Town of Pendleton.

Food Vendors:

The food vendor must prepare all food products prior to sale. Resale items shall not be sold at the Market. All food vendor products must complement the mission of the Farmers Market as determined by the Town of Pendleton. **All food products must be prepared in a SCDA approved/certified kitchen.** Prepared Food Vendors will be subject to inspection by the market manager or representative of the Town of Pendleton. **NO PETS ALLOWED ON GREEN DURING EVENTS.**

NOTICE: ALL vendors are responsible for obtaining all licenses and or permits required by DHEC, SCDA and any county or other state agencies.
